Please remember our clients in your prayers

Please pray for A, a 20-year-old mom who lives with her 4-year-old son. A was a victim of human trafficking. She just started a job but only made \$248 the past 30 days and is two months behind on her rent payment and now owes \$714.

Please pray for A, a 44-year-old mom who lives with her husband and her son. A had to have her leg amputated several months ago after multiple surgeries due to blood clots that were forming in her leg. She had to quit her job in health care. Her husband is working but does not make sufficient income to cover all their expenses. They owe over \$1000 on their gas bill an it has been off for over 3 months.

Please pray for D, a veteran who has not been able to work for the past 5 months due to mental health issues. He has been released to go back to work and is currently looking for a job.

Please pray for C, a 27-year-old mom with two young children. C has not been able to work as she is recovering from injuries from domestic violence. She currently owes \$788 on her rent and \$812 on her Evergy bill.

Please for H, a 60-year-old homeless man we helped to get into an apartment. He is a veteran and just started working at a job which gives him 15 hours per week. He made \$550 in the past month.

Please pray for B, a 32-year-old mom with 3 children who is currently going through a divorce. She has no income at this time.

Please pray for C, a 41-year-old man who lives with his 13-year-old son. C has been off work for the past 5 weeks due to health issues and his vehicle stopped working. He owes \$950 on his Evergy bill.

Please pray for M, a 38-year-old mom with 3 children and is expecting another child. One of her children is disabled and she currently is on bed rest. She hopes to be able to return to work when school starts. She owes over \$2000 on her utility bills.

Please pray for B, a 29-year-old lady who is recovering from her addiction. We were able to help her get into a recovery home. She currently has no income.

Please pray for M, a 51-year-old homeless lady we were able to help get into an apartment. She had just been recently separated from her husband and was assaulted while living out on the streets.

Please pray for K, a 50-year-old lady who only made \$800 on her job this past month. Her electric and gas service are both turned off at this time and she owes \$2800 on her utilities but is current on her rent.

Please pray for J, a 31-year-old mom with 4 children who works for the school district but due to being off for the Summer has had very limited income and could only make \$281 this past month. She owes \$660 on her rent and has an eviction notice and owes \$615 on her utilities.
