PRAYER REQUESTS

• Please pray for C a 78 year old grandmother living with her 11 year old grandson. C is currently receiving treatment for lung cancer. Her grandson lives with her as her daughter is on drugs living with her boyfriend and not able to care for her son. Her daughter has physically abused C, but C has not reported her as she is afraid her grandson will be taken from her. He is the most important thing in her life.

• Please pray for C, a 49 year old mom who lives with her teenage daughter. C in on the list for a heart transplant. She does receive Social Security income but her monthly mortgage payment of \$746 takes most of her income.

• Please pray for J & A who live with their 6 children. The 12 year old daughter is receiving social security income related to her cancer. J lost his job at the first of the month and has only made \$75 at a temp service. They owe \$800 on their rent and have an eviction notice.

• Please pray for M, a 54 year old lady who cleans houses for a living. She was ill and not able to work the past 2 months. She owes \$730 on her rent and \$980 on her utilities.

• Please pray for S, a 36 year old man who has just been released from treatment for his drug addiction. He is moving into a recovery home. • Please pray for T, a 34 year old mom with a 2 year old daughter. She has been on maternity leave and not able to work. She is especially grieving as her 2 month old son suddenly passed away. She owes over \$1000 on her Evergy bill.

• Please pray for I, a 35 year old mom with 3 young children. The home they are living in has mold and the children have been suffering with asthma attacks. She is trying to move into a new apartment.

• Please pray for D, a 60 year old man who lives by himself. D lost his job and was receiving unemployment benefits, but had 3 heart attacks this winter. He is unable to work due to the heart attacks and has now lost his unemployment benefits as he cannot apply for jobs due to his medical condition.

• Please pray for L, a 34 year old man who is homeless and living in the shelter. He does receive social security income of \$747 per month. We helped him move into an apartment.

• Please pray for J, a 68 year old man who lives with his 43 year old daughter. J has been in the hospital with cancer and his daughter is on oxygen and dialysis. They owe over \$3000 on their utility bills.

For the past 9 months, the Center of Hope prevented 1,684 families from having to experience home-lessness. Included in those families were 4,297 persons. \$743,372 was dispersed for rent, utilities and emergency needs.
